## 2.0 NEW BUSINESS

2.1 Closed session: PUBLIC EMPLOYEE APPOINTMENT. Title: Fire Chief.
Pursuant to Government Code Section 54957(b), the Board will consider candidates for appointment to Fire Chief

Director Pratt outlined the purpose for meeting today was to interview for Chief's position. There will be a board panel and an interview panel. The interview panel is a standalone committee solely for the purpose of interviewing for Chief. It is an advisory committee that will be dissolved once this day has been completed. The interview panel consists of Clive Savacool, Chief form Garden Valley Fire Protection District, Dan Dwyer, the past interim Chief and PVFA representative, Chief George Selig, the current interim chief, a representative from the local fire fighters union and 2 community representatives, one gentleman from the Showcase Ranches community who has a fire fighter background, and one from the Grizzly Flats Fire Safe Council.

2.2 Action Item: Consideration of Advisory Committee Recommendation Regarding Chief Appointment and Recruitment.

Report out form the Interview Panel Provided by Representative Clive Savacool. After interviewing both candidates for some time we recommend Mark Matthews. He has an extensive background and knowledge of the fire service, articulates himself well, and has a good background with labor management and mutual aid programs. It was a unanimous recommendation by the panel.

Designation was made that the chief's position should be designated as an "at will" position during contract negotiations. Chief Clive Savacool offered to modify his contract with the details of our employment contract and provide a template for the district to use.

2.3 Closed session: PUBLIC EMPLOYEE APPOINTMENT. Title: Fire Chief.

Report out by the board: By a 3-0 vote the board appoints Mark Matthews pending satisfactory conditions of employment and agreement as the next Chief.
