7.1 Fire Chief's Report

Dan Dwyer reported that County wide tax measure has died.

The water rank at Omo Ranch has been completed. The funds to complete this project came from PVFA. The cost was approximately \$3500.00 Omo has a new electrical panel, the water tank has been re set and permits have been signed off. The tank is self-filling and all is in compliance. The Health and Safety fair was a big success. Coverage of the event will be in this month's issue of the El Dorado County Style Magazine

Chief Selig reported that we will be doing a Driver Operator 1A and 1B. 1A training will be held at Station 38, and 1B will be done at Red Hawk. KME requested last week to have a photo shot with Engine 38 that will appear in some national publications. The website is almost ready to launch. Captain Gardiner went to Sierra College Fire Academy to do recruitment with the graduation class. One application has been received. Personnel are currently completing the annual Wildland Red Card Refresher Training. The JPA will be voting on their new budget.

The funds can be used to reimburse counties for search and rescue, training costs and equipment purchases directly related to emergency services. They are also offering funds for salary and wages of emergency response personnel, replacement of equipment, material and supplies expended, damaged or destroyed, repair of equipment damaged during an emergency response, maintenance of vehicles and equipment. The grant is through the County Board of Education. We search for grants each year. Captain Morford has been doing a lot of the recent grant work. Eileen will provide information to Chief Selig to provide to Captain Morford to pursue.
