Candidates were informed about the terms open and length of time for each open position. Appointment 1 will serve until December 7,2018, Appointment 2 will serve until December 4, 2020. Candidates were also informed they would need to run for the positions in the next election. Marie Fitts was willing to serve either term, Paul Graham and Eileen Strangfeld were interested in the one year term

Marie Fitts was sworn in by Director Pratt for Appointment 2 serving until December 4, 2020.

After swearing in the new directors joined the board for the remainder of the meeting.

6.4 Update on Chief Position

10 applications for Chief have been submitted. Currently the Chief's job posting is on the Pioneer website and on the website Indeed. There are 2 other websites available to advertise the open position of Chief, but fees are required to utilize them. International Association for Fire Chiefs, and Daily Dispatch. Applicants from California would be preferable due to knowledge of California rules and regulations.

Create an adhoc committee for recruitment of interim Fire Chief.

Justification

- (1) Parallel process to the permanent solution
- (2) No Board level plan in place Ops yes, Board no
- (3) Recruiting process in finding the RIGHT candidate for Chief is of an undetermined length

Kathy Wood asked about the possibility of having a Captain stepping up and fill the duties of Chief until a permanent Chief can be found. Allen Wood stated there are already policies in place for a Caption to step up into the Chief's role for a limited term, and contracts are available.

Director Pratt stated there is a cost to posting jobs on several websites that would be of value in the process of recruitment of the new Fire Chief. Discussion took place regarding creating a line item on the budget to reallocate funds for this process.

Public member Allen Wood provided clarification on how the budget process would allow for funds to be used for hiring of a new Chief. Funds can be spent by the Fire Chief and put through the green sheet process and allocated to an appropriate category. No Motion was made.
